## Privacy Notice

### 1. Introduction

Bontebok Limeworks (Pty) Ltd, Registration Number 1947/025665/07 (“**We**” / “**Our**”/ “**Us**”) respect and protect your right to privacy. Our Privacy Notice (“**Notice**”) applies to everyone (both natural and juristic) whose personal information We collect. This includes Our employees, consumers and customers, vendors, contractors, service providers and other third parties.
